





The shower enclosure shall be Aquarius Model G 6233 BF center,right or left. Finished surface shall be of a sanitary—grade polyester Gelcoat exhibiting a minimal thickness of 15 dry mils and a finished cured Barcol hardness of 80—90 as tested with ASTM D—2583. Unit construction shall be of molded reinforced fiberglass with a 15% minimum fiberglass content. The unit shall have outside dimensions of 62" x 33" x 80". The base shall be attached to the sump of the unit in such a manner as to form an integral part with an inner and outer coating of reinforced polyester resin. The unit shall meet ANSI 117.1, ANSI 124.2, ADA, HUD, BOCA, NAHB, UPC, and shall meet the requirements of Southern Building Code.
